## Box 1:

- Books and journal articles written by Marvin N. Olasky. 2 copies each of most titles.

## Box 2

- Correspondence, memos, articles, manuscripts relating to Olasky's editorship at *World* magazine and teaching and writing about journalism.

## Box 3

- Personal papers of Marvin Olasky, including manuscript copies of his dissertation, high school yearbooks, daybooks and calendars, greeting cards, and his father's Harvard thesis. Also included are files of radio scripts from the 1980s, writing/notes on baseball, travel, cartoons, children, DuPont, Dinesh D'Souza/The King's College, NY.

- More books and collected essays written or edited by Olasky. Also included are his reporter's notebooks from 2022-2023.

- Files relating to Compassionate Conservatism, including clippings, articles, speeches.

## Box 6

- Letters to the editor; speeches, newspaper and magazine clippings, ca. 1989-2020. Also includes copies of theses and dissertations on the topic of World magazine or Marvin Olasky's compassionate conservatism. Also contains various media (cassette tapes, VHS tapes, and DVDs) of Olasky's appearances/talks over years, including World Vision, Moody Broadcasting Network, prayer breakfasts, conversations between Olasky and Jim Wallis, Breakpoint, College Church, Wheaton, IL; New Jersey Right to Life Convention; Center of the American Experiment; The American Experience; Veritas Forum; C-Span; Hillsdale College. Also included are digital photos on CD of Olasky's travels to Africa, Cambodia, Japan, Cuba, and India.

## Box 7

- Files on various theological positions and studies, including Olasky's 1984 study guide on Calvin's Institutes; ethics in journalism; theological positions at King's College; manuscripts revisions for *World View: Seeking Grace and Truth in Our Common Life*; Bible study notes and outlines; the PCA's 50<sup>th</sup> anniversary commemorative publication; copies of Olasky's course packs from UT Austin, Fall 1988 and Spring 2000; notes on debate with Christopher Hitchens. Also includes more copies of Olasky books.
